In purchasing a puppy from us, you agree to enter a spay/neuter contract agreement, unless this puppy is sold to you as a breeder. This means you agree to spay/neuter the pup before one year (12 months) of age.

Breeder warrants that the puppy has had dew claws removed. Breeder warrants that the puppy has received the first set of puppy vaccinations. Breeder warrants that the puppy has been wormed. Puppy will receive a health check from a licensed veterinarian prior to buyer(s) picking up puppy.

Buyer(s) have 96 hours (4 business days – including Saturday) to have their puppy examined by their veterinarian or this contract is null and void. Additionally, in the case where the puppy is purchased for breeding, a health certificate should be acquired, and a copy should be forwarded to seller(s) within seven business days (including Saturday).

If, because of the examination, the veterinarian determines that the puppy is not in good health, the buyer(s) may return the puppy to seller(s) for a full refund of the purchase price, not including shipping, return costs or veterinary bills.

This contract guarantee covers your puppy until One (1) year of age against any genetic or congenital disorder that adversely affects the health of your puppy.

If there is a genetic or congenital disorder, a written and detailed report from the attending veterinarian must be provided that proves conclusively a preexisting genetic or congenital condition is present in the animal. The guarantee is void in the event of an undeterminable or inconclusive diagnosis. Seller(s) must be notified within eight days from the diagnosis. All veterinarian fees will be paid by the buyer(s). Buyer(s) agree to allow seller(s) veterinarian to review all documents surrounding any claim to determine the appropriate course of action.

**Please note:** This guarantee does not include any illness due to the ingestion of foreign objects, improper food, chemicals, physical injuries, hernias, heat stroke, environmental factors or improper socialization. Hypoglycemia, intestinal worms, giardia, and coccidia are NOT covered under this guarantee. The latter three are common intestinal parasites found worldwide, so 100% parasite free cannot be guaranteed. This guarantee does not cover viral or bacterial infections, parvo, distemper, or coronavirus, kennel Cough, pneumonia, Lyme disease, heartworm, rabies, or lack of required annual vaccinations. We do not include the following in our guarantee: skin problems, allergies, or eye lid problems. This guarantee does not cover behavioral or training issues. This guarantee does not cover any injury sustained to the puppy by other acts such as an injury from another animal or accident with a vehicle.

Every reasonable precaution has been taken to prevent this puppy from acquiring any hereditary health defects. Due to the unknown hereditary and environmental causes of such defects, we do not guarantee OFA hip clearances (or other hip test such as PennHIP, etc.) for any puppy purchases. We pride ourselves in giving you the best bred Bernedoodle.

Only for genetic or congenital reasons that adversely affects your puppy will seller(s) replace the puppy free of charge or refund ½ of the purchase price to offset medical expenses. Should you opt to replace the puppy, a replacement puppy of equivalent value will be made available to you as soon as availability permits. We do not require, but may reserve the right, to have the

puppy in question sent back. Buyer(s) is responsible for the total transportation cost of the replacement puppy.

**If, for any reason, Buyer (s) is unable to keep this puppy, I shall be given the first right of refusal.** At the sole expense of the Buyer (s), the puppy shall be returned to my possession and control and the Buyer (s) shall execute all necessary documents to transfer ownership back to me.

This puppy shall not be used in any dog fighting operations, nor puppy mill operations, or sold to a breeder, nor produce puppies for resale in pet shops, labs, or any organization whose intent is to resell, trade, or give away puppies to be used in any lab experiments. In the event of the breach of contract I, (buyer), do hereby agree that the breeders may obtain return of the dog without any monetary reimbursement to the owners and shall be due the sum of One Thousand US dollars in liquidated damages incurred to the reputation of the breeder's kennel name.

**Size/Weight/Color:** We estimate the adult size, weight, and color; however, this is only an educated guess and is not guaranteed. This guarantee does not cover these items and no reimbursement/exchange will be made should these items differ from the estimate given.

This contract is made and signed by both parties to ensure the well-being and protection of this puppy. This contract constitutes the full agreement between buyer(s) and seller(s). No other warranty, verbal or written, is implied.

Please note: When you purchase a puppy from us, you are agreeing to the terms of our contract whether you sign it or not.
